Textual Information()

Request received vide letter dt 27.05.21 from Mrs V Shyamala [W/o R Vaidyanathan, Registered Nominee for the Shares held by Mr R Vaidyanathan (Deceased), Promoter) for reclassification of 2500 Equity Shares held by her husband (Late Mr R Vaidayanathan) from "Promoter Category to Public Category" and further stated that due to her advancing age she is not interested to continue as promoter, if the above said shares are transmitted to her name (Mrs V Shyamala). The matter was discussed by the Board of Directors of the Company at their meeting held on 31.05.21 and the Board decided to reclassify the said 2500 shares from the category of Promoter to Public. The matter was placed at the AGM of the company and sought approval from the shareholders at the AGM of the company held on 07.08.2021. Based on the consent of the Board of Directors and approval of the shareholders of the Company, an application (No.137295) along with necessary documents was submitted with the Stock Exchange (BSE Ltd) on 31.08.2021 for reclassification of 2500 Equity shares held by Mr R Vaidyanathan (Deceased) from Promoter Category to Public Category and in order to effect the reclassification, the 2500 Equity Shares of Mr R Vaidyanthan has been transmitted to his wife (Registered nominee) Mrs V Shyamala on 17.03.2022. Due to transmission of Shares of Mr R Vaidyanthan, (Deceased), Mrs V Shyamala has come under the Category of Promoter of the Company as per Regulation 31A(6)(a) of SEBI (LODR) Regulations, 2015, automatically. On approval of the reclassification application by the stock exchange, Mrs V Shyamala and her 2500 Equity shares will be reclassified from Promoter Category to Public Category of the Company.
